

Completion Rates by Degree Type











System Transfer Student Completion Trend




3 Year Workforce Student Completion Rate: 2020 Cohort




System Workforce Student Completion Trend









System Workforce Student Post-College Employent Trend





System Transfer Completion Rates by Race/Ethnicity




System WorkForce Completion Rates by Race/Ethnicity










